- 1. Akim was working in his farm some days ago when he saw Mr Bintu walking across his farm with two other persons. Mr Akim walked up to them to find out what they were doing on his farm but they ignored him. Akim later brought an action against Mr Bintu and the two strangers. In their defence they argued that they did not destroy any crop but were merely using the foot path in the farm as a thoroughfare due to flooding in the entire land area. While Mr Akim was still arguing with Mr Bintu, Mr Goodluck brought out a gun from his pocket and pointed it at Mr Akim who fled .Mr Akim was knocked down by a reckless unlicensed driver and was carried to hospital in very critical condition. Mr Akim is the bread winner in his community. His uncle suffered heart attack when he heard of the accident and was also hospitalized.
  - (a) What are the chances of Mr Akim succeeding in an action for damage to his land and claim for his medical bills
  - (b) What are the chances of Mr Bintu and Mr Goodluck succeeding in their defences to Mr Akim's suit
  - (c) What are the chances of Mr Akim's uncle succeeding in his claim
  - (d) What is the new test for determining the extent of liability for damage and its advantage
- 2. With the help of decided cases discuss;
  - (a) Legal wrong without damage: Injuria sine damno
  - (b) Damage without a legal wrong: Damnum sine injuria
