Feminist movements also actively link women's rights to the empowerment of women and eradication of poverty. This is because, poverty can be interpreted in a wide sense, as including not just a lack of financial and social resources, but an exclusion from health care, legal services and civic life. Generally, women work longer hours than men, with at least half the total time spent in unremunerated labour. This invisibility leads to 'lower social entitlements to women as compared to men. This situation engenders gender inequality by perpetuating gender gap in accessing limited resources.
