#### Question 1

Shortly before Mr. Komolafe made his Will, Miss Lucy whom he acknowledged as his mistress told him "Remember all my sufferings with you all these years, they should not be in vain, while you write your Will". Mr. Komolafe died July 15, 2019. In his Will, he made the following disposition amongst several others

Clause 1-My house at No.5, Charlie Boy Street, Lagos state to my bosom friend Mr. Andrew Richard of the same address.

Clause 2- Block of 4 flats at 7, Public Street, Maitama, Abuja to my mistress, Miss Lucy.

Clause 3- A Toyota Prado Jeep to Kolapo

Clause 4-The remainder to all my children in equal share.

- a. Comment on the proprietary or otherwise of the inclusion of Mrs. Esther Richard as a witness to the Will, and the statement of Miss Lucy in relation to the Will.
- b. State the nature and type of gifts in clauses 2, 3 and 4 and your observations in respect of the clauses, the effects of clause 4 if it is not included in the Will
- c. Draft the Execution and attestation clauses to be included in the Will.

#### Question 2

Architect Julius Olopade married his wife Dr. (Mrs.) Luara Olopade in 1950 under native law and custom. In 2018, Architect Julius made a Will and deposited at the High court of Oyo state. In 2021, Architect Julius reaffirmed his marriage with his wife, Laura Olopade at the Ikoyi Marriage Registry, Lagos State. Shortly after the celebration, Architect Olopade died. His brother –in –law, Judas challenged the Will that the testator's Will already stands revoked by virtue of the marriage celebrated in 2021 at the Ikoyi Marriage Registry, Lagos.

- a. Comment on the statement of Judas in relation to the Will of Architect Julius. Support your answer with statutory and judicial authorities if any.
- b. Assuming you act as solicitor to Architect Julius, itemize the points you will note to draft his Will and your advice on when it will be necessary for him to prepare a new Will
