QUESTION 1.

Mr Jumbo has been ill for the past 3 weeks. He applied for 3-days casual leave from his office to treat himself and it was approved. On the day he was to resume, he fell ill again and had to be rushed to the hospital. He had no way to reach his office to inform them of his relapse. He was subsequently away from work for 1 week.

Upon resumption, he received a query form the Human Resources department, asking him to explain his absence. He was given 48 hours within which to reply. Unfortunately for him, he fell ill again after 24 hours and couldn't submit his response to the query.

The office has sent him a letter of summary dismissal for absconding from work.

- a) Explain the concept of summary dismissal
- b) Advise him on any possible remedies available with the aid of decided cases.

Mr. Festus who owns an interior decoration company has collected a contract to paint Mr.Elaigwu's house. Mr Festus specifically asked that the interior be painted with blue satin paint from Dulux. He has also specified the exterior be painted with Sandcoattexcoat. The contract signed specified that he would not take anything less.
