 - c. Babatunde while on his journey to Dubai instructed his Wife Chinenye to represent him at the wedding of his colleague Chukwuka , what will be the legal status applicable to Chinenye and the legal implication as regards the husband's instruction.
 - d. Madam Bimpe Olole a full time house-wife sent Alainikanse a boy in the neighbourhood to Arambara Local Supermarket in Agege to purchase a loaf of bread for her and on her behalf, what will be the legal status applicable to Alainikanse and the legal implication as regards his relationship to Madam Bimpe Olole.
5. Expressly embark on a voyage of examining the major characteristics that underlines the creation of agency relationship vis-à-vis the identification of the types of agency authority existing using appropriate judicial authorities.
