Question 1

Norman who has been watching them begins to vomit. Mrs. Bameyi hears him and runs to help. She slips on the floor and falls breaking her hip.

That evening whilst the moonlight is up Tunde and Ologun are on their way home from the local pepper-soup joint. Responding to a dare from Tunde, Ologun ignores signs outside the complex stating 'the pools are closed between 10 p.m. and 7 a.m. no entry'. He climbs the fence surrounding the pool and dives into the pool. He hits his head and sustains severe concussions his new iPad is ruined in the process.

What issues of tort arise in this scenario? 25 Marks.

- i. Not every act of inconvenience or annoyance can in law amount to nuisance. Discuss.
- ii. The defendants, a firm of solicitors, employed a managing clerk who was authorized to do conveyancing work for the firm. The clerk induced the plaintiff who owned a number of properties, to instruct him to sell the properties. He then persuaded her to execute this documents, which he falsely told her were necessary for the sale, but which infact were conveyances of the properties to himself.
