Mr Joshua says the work reflects the notion that beyond literal legibility and metaphorical ideas, sculptures should be ambivalent in the meaning and identity. The winning "Obgodo" sculpture will be displayed at Freedom Park in Lekki. Judges praised the sculpture as a great intellectual depth and exceptional beauty.

olu shoyinka, a journalist and an art critic writes an article in an art magazine that is highly critical of Mr Joshua's sculpture. The article includes photographs of a series of a giant tin mental sculptures that look alot like the "obgodo" claiming that they are other works of genius by Babajide otumba.

After a month on display at Freedom Park in Lekki, Emeka Uba, who resides in Lekki near Freedom Park, decides to recreate the "obgodo" in clay in a miniature version. She gives one of the clay sculptures to Kelechi Obi as a wedding gift.

A buyer for ShopRite sees it while visiting kelechi obi after the wedding reception and places an order for 100 more clay sculptures for his store in the palms mall.
