- 1. Women's rights seek to challenge and break down the exclusion, discrimination and violence that women have suffered in all parts of the world. Women's rights could be related to feminism as a cultural and political force. Feminism can be understood as a broad based and diverse movement that seeks to protect and promote the interests of women. Feminist movements also actively link women's rights to the eradication of poverty; a factor that increasingly drives forward the rights agenda. This is because, poverty has to be understood in a wide sense, as including not just a lack of financial and social resources, but an exclusion from health care, legal services and civic life. On the whole, women work longer hours than men, with at least half the total time spent in unremunerated labour. This invisibility leads to lower social entitlements to women as compared to men. This gender inequity in turn perpetuates the gender gap in accessing needed resources.
