- (b) Discuss the relationship between the principle enunciated in the case of *Donoghue v*. *Stevenson* and the concept of environmental protection. **25 marks**
- 2. Favour bought a plot of land which unknown to her does not have a good root of title. She later sold the land to Zion who later obtained a C of O on the property. 10 years later while Zion was using the land as a quarry, her engineers discovered oil in commercial quantity. Consequently she established Zion Oil Company and commenced exploration. Within three years the business had expanded and was doing well. The Federal government approached her for partnership but because of some personal misgivings she has about the Minister of Petroleum, she turned down the request and opted to partner with the Lagos state government. The Lagos state government made substantial investment in the company. Two years later the Federal government sought to acquire the entire land which Zion resisted. government offered to pay compensation but she also turned down the offer. Last month the Federal government demolished all installations on the land, drove the workers away and commenced the use of the land. Zion has gone to court. The Lagos High court upheld her claim over the land and awarded her damages. The Federal government has approached you for advice. Advise them.
