- 1. Akpaka village is a popular village located in Umuakpu Community. They are well known for their communal efforts in bringing development to the village and the entire community. However, there is a popular stream called Okabe which constitutes a serious hindrance to people's movements during rainy season except for the few who can swim well. The situation has been a source of concern to the whole villagers especially the traditional ruler. Consequently, the traditional leadership of the village had consulted and concluded to tax all the male adults in the village in order to raise fund to build a bridge across Okabe stream. Every male adult of the village by this rule is obliged to pay a sum of N25,000.00 for this gigantic project. However, Mr. pompous who saw no reason for this project and had resisted it from inception has refused to pay as agreed by the villagers. All efforts made to persuade him to comply with this directive had proved abortive. The governing council of Akpaka village has now concluded plans to file action against Mr. Pompous on ground of tax evasion.
