QUESTION 1

Ahmadu felt sorry for Onome for the loss of her job not long after buying his car. He told her that if she paid him the half of what she owed him (=N=625,000) by the following month, May 2021, he would let her off with the rest. Onome paid him the N=625,000 on the 25th May 2021. She also sent a thank you card and carton of juice "in consideration of his kindness."

On the 28th of May 2021 Onome was notified that she had been successful in one of her job applications and would be starting work at a much better salary than her old job on the 1st of June 2021. Ahmadu has heard about Onome's new job and realizes that she is likely to be earning more than he is. He now wishes to claim the rest of the money which she had originally agreed to pay for the car.

Dada then found that he did not have enough money with him to do so and said he would call in on Monday to give it to Suru.

On Sunday, Dada agreed with his friends Idris and Chike that they should go to the local Casino while on their way, Idris said: 'If any of us makes a winning let's say more than N100, 000, how about we share the winnings?' The others both agreed that this was a good suggestion. At the Casino, Chike was lucky in all his bets, and at the end of the evening had won N600,000. He then denied that he had agreed to share his winnings and refused to make any payment to Dada and Idris.

- a) whether he is obliged to pay the N20,000 to Sura (since Dada is now short of money after his visit to the betting centre). **8 Marks**
