Mr. Beme had immovable properties in Plateau, Lagos, Port-Harcourt and Abuja. Letter of administration were granted to his widow and eldest son, Danga Beme. The widow declined to administer the estate. In an application to set aside the letters of administration instituted by the oldest son, Danga Beme, Mrs. Suani Beme, on behalf of the other beneficiaries of the estate, applied for the distribution of the estate to all the beneficiaries in accordance with the administration of estate law. The matter went on appeal to the Supreme Court. One of the objections raised on appeal by Mrs. Suani Beme and others was that some of the properties were outside Jos, Plateau State and the High Court of Plateau State, was incompetent to adjudicate on any issues relating to them.
