But with her little exposure, Bante has vowed to resist the attempt by her uncle to dispossess them of their father's property. Being angered with this decision, Fearless has issued many threats to deal with them, one of which threats materialized last month when he physically assaulted Bante and her mother for daring to ask him question over the harvest of the entire pear in their compound.
