#### **QUESTION 1**

Consequently, the offer would remain open till 22/3/2022, failing which he would be at liberty to trade it in with Huawei Mate 9. He stated in the letter that anyone interested should send his/her acceptance by email to his nephew (<u>jidenefew@lawclass2022.ng</u>) before the date.

Your advice has been sought to the following legal situations thrown up by the above facts:

- (a) Inalegwu did not receive Babajide's letter. Without any knowledge of the letter, he initiated a letter to his childhood friend, Babajide on 18/3/2022, enquiring and offering to buy buy Huawei Nova 9 for N220,000.00. (5 marks)
- (b) Umar replied through Babajide's nephew on 20/3/2022 offering to pay N195,000.00, because the phone is neither an Android operating system nor an iOS operating system. On a second thought, he changed his mind and on 25/3/2022 he wrote another letter offering to pay the N220,000.00 asked for by Babajide. Both letters were received at the same time. (10 marks)
- (c) Emike wrote to Babajide requesting further information about the general condition of the phone, standard features and serviceability. Failing to hear any response from Babajide, Emike posted a letter on 19/3/2022 accepting the offer. She addressed the letter to Babajide. (5 marks).
- (d) State the principle of law laid down in Carlill v Carbolic Smoke Ball Co (1893). (5 marks)
