#### **QUESTION 1**

Great Innovations Africa Ltd is a budding Nigerian IT firm. Its clients network services providers, food and beverages manufacturing entities, among others. Over the past four years, the company has posted consistently an annual turnover in excess of NGN500 million. The company is focused on building a strong governance and compliance system and has retained your services to advise her on the following:

- (a) The managing director has a nephew who is a trained business systems consultant. He has decided to recommend him to the board for appointment as the company secretary. With his nephew on the position, the business strategy of the company anchored on growth, prosperity and sustainability will be boosted. Advise the managing director on the propriety or otherwise of the decision. (8 marks)
- (b) The company has a strong and diversified board of directors. One of the board members, Ms. Adenike Jones, is a member of the Association of National Accountants of Nigeria. To cut cost and boost firm value, it is proposed to appoint her as the secretary. Can she hold, and act in, the two positions at the same time? (5 marks)
- (c) At an annual colloquium on Cybersecurity and Data Protection Systems held in Warsaw Poland, the secretary represented the company. When she returned from the trip, the Internal Audit department raised queries on her settlement. It was discovered that she uttered the hotel receipts and claimed three extra days of stay in the Mariupol, where she went to see her cousin, a student at the Mariupol College of Cybernetics and Artificial Intelligence. The board seeks to dispense her services and requests for your professional guidance in this respect. (12 marks)
