# **QUESTION 1**

Section 15(1)

If an inspector believes on reasonable ground that:

- (a) An escape of dangerous goods has occurred or is occurring from a container, packaging or means of transport used in their handling or transport;
- (b) An emission of ionizing radiation exceeding levels or quantities permitted under the *Renewable Energy Act* has occurred or is occurring from any such container, packaging or means of transport;
- (c) There is serious, imminent danger of such an escape or emission; or,
- (d) Any provision of this Act or the regulations has been or is being contravened,

The inspector may take any measure referred to in subsection (2) that he or she considers necessary to prevent or reduce any serious, imminent danger to life, property or the environment.

# Excerpt A: Disposal, etc., of public roads.

**1.-(1)** The Minister may not sell, lease or otherwise dispose of a

Public road under the Land Use Act until it has been closed under section 12.

(2) the Minister may grant easements, licenses or permits

Over or in respect of any public road.

# **Regulations.**

2.-(1) The Minister may make regulations prescribing all matters

Required or permitted by this Act to be prescribed.

Unless the Minister of Finance is consulted.

# Excerpt B

# Food stores to be kept clean.

**7.-(1)** The occupant of a place in which any article of food intended for human consumption is stored or kept or is exposed or offered for sale must make and keep the place clean and wholesome.

(2) A food inspector may:

(a) enter any such place at any time to inspect any article described in subsection (1), and

(b) If *the aforesaid article* appears to be unfit for human consumption, seize *the said article* and order *the same* to be destroyed or so treated as to prevent the exposure for sale or the use for food of *the same*.

(3) Both the occupant of *such place* and the person or persons responsible for exposing or offering for sale *the aforesaid article* commit an offence and are liable to a fine of \$50,000.00. **20 marks**
