- 1. Chromium has just been discovered in Ezewente a town in Eastern Nigeria. Dilichi, the traditional ruler of Ezewente has approached Agua Mineral Food Company in USA to apply to the Ezewente Council of Chiefs for permission to mine the Chromium and pay royalty to Ezewente community. Advise
 - a. Agua Mineral Food Company on the provisions of the law applicable to ownership of the Ezewente chromium as well as the procedure and obligations for exploring same. (12.5 marks)
 - ii. Dilichi on Ezewente's rights to the proceeds of the exploration and payments due to the Ezewente community under the principle of derivation. (12.5 marks)
 - 2a Discuss the elements of a joint tenancy. (8 marks)
 - b. Abraham and Jonah are joint tenants. Following the death of Jonah, his girlfriend and children wish to approach Abraham seeking to be recognised as inheritors of Jonah's interest. Advise them. (7 marks)
 - 3. a. Making reference to Justice Vaughan's example in *Thomas v. Sorrel* discuss
 - i. the nature of a licence coupled with a grant (4 marks)
 - ii. the essential distinction between a licence and a grant. (4 marks)
 - b. Discuss the effect of the Land Use Act on free hold interest (7 marks)

- 4a. Elenu was invited to perform for 10 minutes at the Wild Child Comedy Show for a fee of N500,000. Elenu however agreed to collect N450,000 in exchange for a VIP ticket valued at N50,000 which would entitle him to a front row seat to watch the entire show. Wild Child also agreed to allow Elenu bring his girlfriend. During Elenu's performance, he insulted one of Wild Child's major sponsors. He was therefore asked to leave the show with his girlfriend. When they refused, they were dragged out of the venue in full view of all attendees and fans.
