**QUESTIONS:**

- 1.** Chief Okezie is a popular business tycoon and a well-known social philanthropist who has various business outfit in a popular city of *Akpatakpa*. His community people have unanimously chosen him to represent them in the Federal House of Representative, a choice that was born out of his numerous achievements and community development projects which he single-handedly carried out. He has been a means of succor and source of encouragement to the less privileged in the community through his uncommon act of generosity. However, due to ignorance, Chief Okezie has been against the government which he sees as being exploitative and selfish in taxing the people. He has questioned the rationale for the imposition and collection of tax from the citizens. He has always accused the tax agencies and in several occasions threatened to sue them on the allegation of their incessant efforts to assess his income. Chief Okezie sees this move as unwarranted disturbance to his peace. As an expert, Okezie is now seeking for your legal opinion on this issue.
  - (a) As a taxation lawyer, you are required to give a legal advice to Chief Okezie on the reasons for the introduction of taxation system in the society and the likely outcome of the intending suit. **15Marks**
