QUESTION 4

Absolute bar prevents a court from granting a decree of divorce to a petitioner who has been proved to have committed a matrimonial misconduct. Three types of bars fall within this category –condonation, connivance and collusion. Discuss with respect to the constituent elements in the bar of condonation, namely:

- ii) forgiveness of the respondent (the offending spouse) by the petitioner, being the wronged spouse; and
- iii) reinstatement of the respondent by the petitioner
